What is the HEALTHY TUTOR learning solution?

- The HEALTHY TUTOR learning solution is an advanced, <u>feedback based</u> multi-media education solution for a wide range of acute care, chronic disease, and wellness management initiatives.
- The easy to use internet based design systematically enhances patient and beneficiary understanding of key health concepts in concert with health manager oversight.

What advantages does HEALTHY TUTOR offer the health manager?

- Automatically measures and documents beneficiary and patient member understanding of targeted healthcare management topics.
- Provides the tools necessary to determine the efficacy of member self-management efforts.
- Presents detailed knowledge performance data to guide further decision-making regarding educational needs.
- Ensures high member compliance through an easy to use, web-based referral directed process.
- Enhances return to work efforts and enterprise programs to curb absenteeism and presenteeism.
- Determines the effectiveness of previous educational efforts then re-educates automatically!

- 1) The desired HEALTHY TUTOR session is selected by the health manager and a randomized secure passcode is assigned for one-time use.
- 2) The beneficiary or patient member registers on www.HealthyTutor.com, our easy to use web site. Any broadband connected PC can be used from anywhere...home, work, or clinic by following the easy to use and self-explanatory on-screen guide.
- 3) Upon completion of the educational session, a Performance Summary of the HEALTHY TUTOR session is provided for both member and health manager to view, and save or print. The Performance Summary includes detail of the learning assessment and <u>change in knowledge</u> for the member's electronic or hardcopy local health record.
- 4) The health manager tracks progress of completion, then reviews the Performance Summary and discusses important parameters of topic learning with the patient. Performance on knowledge assessments, rationales of incorrectly answered items, overall progress of knowledge and compliance to the treatment regimen are well documented.

- Once completed by the member, the health manager may review of the printed knowledge assessment results with the member. This effort should be face-to-face with a licensed provider in order to bill insurance for the HEALTHY TUTOR learning session (ask for details).
- Tutorial sessions are maximized for touchscreen PCs in clinics and practitioner offices. These
 units may be mounted to existing office furniture, or mobile carts that can be moved throughout
 exam rooms. Our nationwide team of installation professionals can provide wireless or wired
